Additionally, one day every weekend is dedicated to enriching activities that expand the horizons of Saving Amy's children. We kick off the Saving Amy Bridge and Summer Reading Program in May, enhancing academic skills and preparing them for the upcoming school year. Our tutors/mentors lead a Saving Amy summer camp with engaging activities like ice skating, movies, science museum visits, and picnics.

Rise Up: Comprising two vital components, this program offers essential support through rent subsidies, utilities, furniture, and household supplies. Equally important, it empowers families to escape low-income neighborhoods, fostering hope and brighter futures.

Rolling Forward: Accessible and reliable transportation is key to overcoming homelessness. Additionally, Saving Amy has established partnerships with the Arizona Humane Society, allowing us to acquire vehicles at significantly discounted rates.
